#### **General Description**

The ATM-65 is an aluminum telescoping mast that can be used as a portable mast for supporting small light weight antennas or as an antenna itself.

#### **Directions for use**

The ATM-65 is not self supporting. Guy wires must be used to support the mast when it is extended. Do not attempt to use this product without them. Take care not to bend the mast when collapsed. Any bend or dent in the tubing will prevent it from extending. A minimum of 3 inches overlap of tubing must be used.

#### When using as a mast

The size and weight of the antenna you use will determine where to place it on the mast. For instance, a large antenna should be placed on one of the lower sections of the tubing where the mast diameter is large enough to support the antenna weight. When installing an antenna to the mast, be careful not to deform the tubing as it will prevent it from collapsing.

#### When using as an antenna

A mast insulation kit, such as the ATB-65 or some other means of insulating the mast from the ground should be used. Guying of the antenna will be required if it is extended beyond 30 ft.

- Under no circumstances is *hy-gain* liable for consequential damages to person or property by the use of any *hy-gain* products.
- 4. Out-of-warranty Service: *hy-gain* will repair any out-of-warranty product provided the unit is shipped prepaid. All repaired units will be shipped COD to the owner. Repair charges will be added to the COD fee unless other arrangements are made.
- 5. This warranty is given in lieu of any other warranty expressed or implied.
