Introduction

The MFJ-5007 is a high gain audio amplifier system combined with a parabolic dish reflector giving a narrow beam width high gain system for listening to sounds at a distance. The narrow beam aids in isolating specific sound locations. The amplifier and gain of the parabolic dish aid in pulling out weak sounds at a distance.

The MFJ-5007 is ideal for tracking bird and animal sounds, sporting events, and locating other sounds that may be hard to identify at a distance.

Operation

- Install a 9V battery in the MFJ-5007 by sliding off the battery cover on the amplifier case and snapping the battery in place then slide the cover back on.
- Plug in the headphones. The MFJ-392B is included but most any other low impedance headphones that will block out local sounds will work.
- Turn on the MFJ-5007 with the thumbwheel switch and volume control, adjust the volume for a good listening level, and point at the sound source you want to hear.
