MFJ-5902 Resistor–Capacitor Box

Introduction:

The MFJ-5902 Resistor-Capacitor Substitution Box combines a ½-Watt 10-K potentiometer and a two-section 350-pF variable capacitor into one handy handheld package. Insulated terminal posts accept standard test probes, patch cables, or hookup wire. The MFJ-5902 is a great tool for experimenters, RF designers, and service techs alike.

Operation:

The MFJ-5902 front-panel markings are self-explanatory with schematic labeling for all terminal posts.



Potentiometer Range:

When rotating the 10K potentiometer fully counter-clockwise, note that the terminal resistance drops to zero ohms -- not the lower (1K) value appearing on the calibrated scale. Always remove power when setting up dc circuits if reducing the potentiometer setting to zero could cause a short! Also, note that the power rating for the potentiometer is $\frac{1}{2}$ Watt. Never connect to circuits that will cause dissipation to exceed the specified rating.

Capacitor Range:

The two-section capacitor is approximately 10-350 pF per section. Three capacitive ranges are possible, depending on configuration:

[] 175 pF: Connect to terminals 1 and 2 (series). Divide scale reading by 2.

[] **350 pF:** Connect to terminal **1** or **2** and **Common**. Read scale x1.

[] **700 pF:** Jumper **1** and **2**, connect to **1** and **Common**, multiply scale x2.

The capacitor's rotor and stator are RF and DC isolated from the aluminum front panel. Limit RF application to QRP range (< 10-W) and dc application to 50 volts to ensure breakdown voltage levels will not be exceeded.
